

The following is information concerning the Equal Employment Opportunity as required by the Federal Communications Commission.

AS Operations Manager/Program Director over all Perry Broadcasting radio stations, I periodically speak as an effort to inform and recruit future employees. The following are brief statements concerning those accounts.

- On **Wednesday December 16, 2005** I was invited to speak to a Programming class at **Cameron University** in Lawton, OK. The invitation came from Steve Adams, the Director of Communications. I spoke to a class of 25 to 30 students about the day to day duties of an air talent with Perry Broadcasting. I covered hiring practices, benefits, procedures and duties required of an intern student and employee. I answered all questions as well as gave contact information for all radio station address, phone numbers and GM/PD contact names.
- Jonathan Lee is a full time employee with Perry Broadcasting in Oklahoma City. Jonathan volunteered to teach broadcasting for the **YMCA Career Enrichment Program**. Jonathan taught classes on **September 17, October 22, October 29, November 19, December 10 and December 17 of 2005**. All classes were taught at Oklahoma City University. During these classes Jonathan covers every aspect of radio as well as extend internship and employment opportunities.
- In the month of **February in 2005** I attended the **University of Oklahoma Athletic Career Fair**. During the career fair I answered questions concerning employment through out the state of Oklahoma for Perry Broadcasting. I spoke to well over 100 student athletes during the 3 hour fair.
